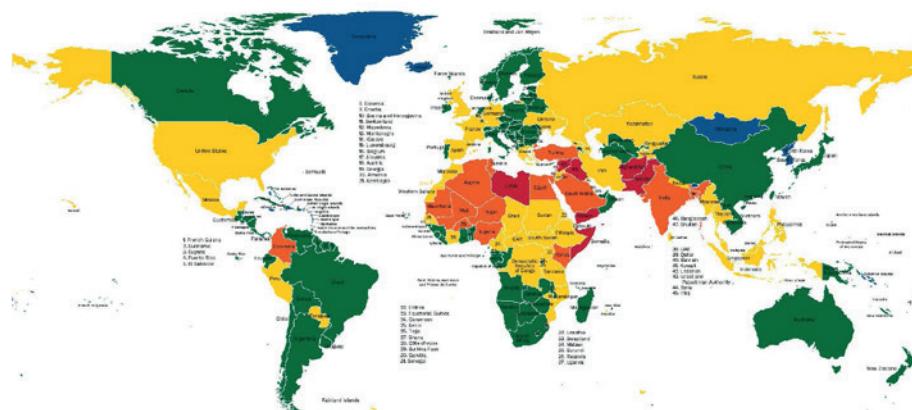


## GLOBAL RISK MAP
